

Guideline: Submission of Honours and Higher Degree by Research (HDR) programs Master of Philosophy, Professional Doctorate, or Doctor of Philosophy to Open Research

Purpose

The purpose of this guideline is to provide information to enable Honours theses to be submitted to the Open Research repository consistent with the Open access policy and procedure.

Guideline

Overview

1. This guideline provides implementation to the [Open Access Policy](#) and [Open Access Research Procedure](#).
2. The ANU Open Access policy requires the deposit of the following in the Open Research repository:
 - a. Higher Degree by Research (HDR) programs Master of Philosophy, Professional Doctorate, or Doctor of Philosophy student theses – immediately upon completion (noting automated deposit through the Research Student Milestone eForm via ISIS, where Notification of Intent (NOI) to Submit has been lodged after June 2018; and
 - b. Honours theses where these have been approved for submission by the relevant Head of School and copyright clearances have been obtained.
3. Honours theses are deposited through the ANU Open Research system with appropriate permissions.
4. This guideline outlines the responsibilities of Open Research, academic staff and Honours and Masters by Research students.

Open Research Responsibilities

5. The ANU Open Research service provides:
 - a. advice and support to students and staff regarding the deposit of theses;

- b. support for allocation of researcher identity, eg. ORCID;
- c. training and advice on research data management and DMPTool, the University's data management planning service; and
- d. management of ANU Open Research repository.

Academic Staff

- 6. Staff supporting honours students:
 - a. advise students commencing their Honours program that all Masters by Research and Honours can be deposited in the Open Research repository if approved by the relevant Head of School and copyright permissions have been obtained;
 - b. refer students to the Contribute your Thesis information page and ensure they use the associated form to deposit their theses; and
 - c. notify Open Research staff before graduation the students who are required to submit theses to the repository.

Students

- 7. Honours students:
 - a. ensure that permissions are obtained for use of third party material in theses;
 - b. when notified by academic or departmental staff that deposit of their thesis is required, will use the Contribute your digital thesis form to deposit their theses and provide permissions;
 - c. ensure that any amendments recommended by examiners are addressed before submission of the thesis.
